### 4. FIRST AID MEASURES

**Large Spills:**

## 7. HANDLING AND STORAGE

**Safe handling:**

Avoid all personal contact, including inhalation.

## Engineering Controls:

Ensure ventilation is adequate to maintain air concentrations below Exposure Standards. Use only in well ventilated areas. Within poorly ventilated spaces, use with local exhaust ventilation or while wearing appropriate respirator. Vapour is heavier than air - prevent concentration in hollows or sumps. Do NOT enter confined spaces where vapour may have collected.

## Personal Protection Equipment:



Safety glasses with side shields. Chemical goggles.

Contact lenses may pose a special hazard; soft contact lenses may absorb and concentrate irritants. **11. TOXICOLOGICAL INFORMATION**

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

<b>Inhalation:</b>	The material is not thought to produce adverse health effects or irritation of the respiratory tract (as classified by EC Directives using animal models). Nevertheless, good hygiene practice requires that exposure be kept to a minimum and that suitable control measures be used in an occupational setting.
<b>Skin Contact:</b>	Skin irritation may also be present after prolonged or repeated exposure; this may result in a form of contact dermatitis (nonallergic). The dermatitis is often characterised by skin redness (erythema) and swelling (oedema) which may progress to blistering (vesiculation), scaling and thickening of the epidermis. At the microscopic level there may be intercellular oedema of the spongy layer of the skin (spongiosis) and intracellular oedema of the epidermis. The material may accentuate any pre-existing dermatitis condition. Skin contact is not thought to have harmful health effects (as classified under EC Directives).
<b>Ingestion:</b>	The material has NOT been classified by EC Directives or other classification systems as "harmful by ingestion". Gastrointestinal tract discomfort may produce nausea and vomiting. In an occupational setting however, ingestion of insignificant quantities is not thought to be cause for concern.
<b>Eye Contact:</b>	Repeated or prolonged eye contact may cause inflammation characterised by temporary redness (similar to windburn) of the conjunctiva (conjunctivitis).
<b>Chronic:</b>	Practical experience shows that skin contact with the material is capable either of inducing a sensitisation reaction in a substantial number of individuals, and/or of producing a positive response in experimental animals.
